SCOPE OF WORK: Furnishing all labor, equipment, and materials necessary to construct approximately 3,960 LF of 6" PVC water main, 1,750 LF of 10" PVC/FPVC (conventional installation/directional drill) water main; fire hydrants, associated appurtenances, cutting and capping existing mains; reconnection of existing water services; connection to existing mains, and associated restoration.
